

PROVINCE OF QUÉBEC MRC LE HAUT SAINT-FRANÇOIS MUNICIPALITY OF BURY

« Bylaw number 417-2014 regarding parking »

WHEREAS article 565 of the Quebec Municipal Code grants local municipalities the power to adopt bylaws regarding parking;

WHEREAS notice of motion was duly given on December 18th 2013 by Councillor Delmar Fisher;

THEREFORE,

IT IS PROPOSED BY Councillor Delmar Fisher, SECONDED BY Councillor Marilyn Matheson,

AND CARRIED THAT bylaw number 417-2014 regarding parking be adopted:

THEREFORE, COUNCIL DECREES THE FOLLOWING:

Article 1

The preamble is an integral part of the present bylaw

Article 2 Municipality

The municipality authorises the person responsible for the maintenance of a public road to install a sign or parking meter indicating the stopping and parking zones

«Responsibility»

Article 3 SQ

The owner whose name is registered at the SAAQ may be declared guilty of a parking infraction by virtue of this bylaw.

«Prohibited area»

Article 4 SQ

It is prohibited to park or immobilize a vehicle on a public road where signs or parking meters indicate such a prohibition.

«Permitted periods»

Article 5 SC

It is prohibited to park or immobilize a vehicle outside the period authorised by the sign or parking meter.

«Winter»

Article 6 SQ

It is prohibited to park or immobilize a vehicle on a public road between the hours of 11:00 pm and 7:00 am from November 15th to March 31st inclusively, and this, in the entire territory of the municipality.

«Removal»

Article 7 SQ

In the course of performing their duties by virtue of the bylaw, SQ officers may remove a parked vehicle or have a parked vehicle removed at the cost of its owner in the case of snow removal or in the following cases of emergency:

- The vehicle hinders traffic to the point of causing a risk to public safety;
- The vehicle hinders the work of firefighters, police or any other official during an event involving public safety.

«Residential zone»

Article 8 SQ

It is prohibited to park or immobilize a truck on a public road in a residential zone, except to make a delivery or carry out a job.

«Residential zone» more than 60 minutes

Article 9 SQ

It is prohibited to park or immobilize a vehicle on a public road outside of residential zones for more than 60 minutes, except to make a delivery or carry out a job.

«Selling and Trading»

Article 10 SQ

It is prohibited to park or immobilize a vehicle on a public road in order to sell or trade it.

«Publicity»

Article 11 SQ

It is prohibited to park or immobilize a vehicle on a public road in order to advertise.

ADMINISTRATIVE PROVISIONS

«Responsible for the application»

Article 12

The SQ officers

«Issuance of tickets»

Article 13

Council generally authorises the one responsible for the application of the present bylaw to issue tickets for all violations of the provisions of the present bylaw and to bring suit in the name of the municipality.

«Sanctions»

Article 14

For every subsequent offence, the fine is double the amount of the initial offence.

«Fines»

Article 15

Whomever contravenes articles 4, 5, and 6 of this bylaw commits an offence and is liable to a \$50 fine in addition to fees.

Whomever contravenes articles 8,9,10 and 11 of this bylaw commits an offence and is liable to a \$100 fine in addition to fees.

«Coming into force»

Article 16

The present bylaw comes into force in accordance with the law.
