9.1 Notice of motion to bylaw number 411-2022 adopting the code of ethics and conduct of elected officials of the municipality of Bury and repealing bylaw number 411-2018.

Councillor Marc Bilodeau gives notice of motion that a draft bylaw number 411-2022 adopting the code of ethics and conduct of elected officials of the Municipality of Bury and repealing bylaws 411-2018 will be tabled with dispensation from reading, for adoption at a future meeting.

9.2 Adoption of bylaw number 440-1-2021 "bylaw decreeing the repair of municipal services on Stokes Street authorizing an expense in the amount of \$1 730 000 and authorizing a loan to cover said expense repealing bylaw 440-2021."

WHEREAS the municipality wishes to proceed with repair work on the municipal services on Stokes Street on a distance of more or less 550 linear metres:

WHEREAS the cost related to the execution of the repairs are estimated at one million seven hundred thirty thousand dollars (\$1 730 000) including incidental fees, net taxes and unexpected costs.

WHEREAS the municipality does not have the necessary funds to pay the costs of the repairs, a loan must be authorized to cover said costs.

WHEREAS on July 72 021, the *Ministère des Affaires municipales et de l'Habitation* confirmed to the municipality the payment of a sum of one million ninety-eight thousand three hundred and four dollars (\$1 098 304) under the Federal Gasoline Tax Program and the Quebec contribution program (*TECQ 2019–2023*) and that part of the sum to be received namely seven hundred and ninety-eight thousand three hundred and four dollars (\$798 304) is allocated to the payment of the costs of the work covered by this bylaw, a copy of this letter being attached to form an integral part thereof as appendix "A";

WHEREAS On June 17, 2021, the Minister of Transport and the Minister responsible for the Estrie region deemed the repair work covered by this bylaw eligible for a payment of six hundred and eighty thousand eight hundred and twenty-eight dollars (\$680 828) under the Programme d'aide à la voirie locale volet redressement and that the amount to be received, if applicable, will also be allocated to the payment of the costs of the work covered by this bylaw, a copy of this letter being attached to form an integral part thereof as appendix "B";

WHEREAS under the terms of article 1061 of the Municipal Code of Quebec, a loan bylaw is only submitted to the approval of the minister for which at least 50% of the planned expenditure is the subject of a subsidy of which the payment is made by the government or by one of its ministers or agencies;

WHEREAS it is in the best interest of the municipality of Bury to proceed with the repair work of the municipal services on Stokes Street;
