# 3. Application for grant Programme de 4500 bornes Hydro-Québec

WHEREAS there is no station accessible to the public for electric vehicles to recharge on the entire municipal territory;

WHEREAS the municipality wishes to offer charging stations for electric vehicles close to the town's core, near the businesses and essential services;

WHEREAS a yearly grant program of 4500 charging stations is offered for a period of 8 years by Hydro-Québec;

WHEREAS each charging station on the street may be subsidized up to an amount of \$24 000 of eligible costs before taxes;

IT IS PROPOSED BY councillor Karrie Parent, SECONDED BY councillor Alain Villemure.

AND CARRIED TO authorize the municipality to submit an application with Hydro-Quebec to obtain a grant for the acquisition of electric charging stations
