4. Purchase of granular material – Hardwood Flat Road

WHEREAS the municipality requested bids from three gravel pit owners for the supply of 0 ¾ MG 20A (crushed stone), to build a 800 ton reserve, destined for the repair of Hardwood Flat Road.

WHEREAS Immediate availability of materials is possible at only one (1) site;

THEREFORE,
IT IS PROPOSED BY Councillor Marc Bilodeau,
SECONDED BY Councillor Vanessa Chapman,

AND CARRIED to authorize the purchase of 800 tons of MG20A granular material from *Gravière Bouchard* at a cost of \$16.07/ton net tax and \$27.93/ton net tax including delivery.

THAT the price includes the royalties and loading, plus taxes:

THAT the amount be taken from the 2024 municipal budget.

5. Purchase of four (4) bunker suits for the fire department

WHEREAS to meet the fire « Schéma de couverture de risques » it is necessary to replace 4 bunker suits for the Bury Fire Department in 2024;

AND CARRIED THAT the municipal council authorizes the purchase of four 4 bunker suits for the Fire Department from CMP Mayer Inc. for an amount of \$9 221.50 plus taxes.

TO allocate the expense to the working capital at the rate of \$968.14, net taxes, over a period of ten (10) years, starting in 2025.
