WHEREAS the Municipality is completing adjustment entries for the financial year which ended December 31, 2022;

IT IS PROPOSED BY Councillor Alain Villemure,  
SECONDED BY Councillor Vanessa Chapman,

AND CARRIED TO adopt the retroactive modifications and corrections for the year 2022:

- Allocation of \$70 280.98 to the unallocated accumulated surplus for the expenses incurred in the years 2020, 2021 and 2022 concerning the municipal garage construction project. Expenses cannot be left to be financed without authorized loan regulations or a signed subsidy protocol. The unallocated accumulated surplus will be replenished when the loan or subsidy is authorized.
- Allocation of \$82 879.78 to the unallocated accumulated surplus to finance past plans and specifications.
  - Expansion plan, plan for a new construction on new land, plan for a new construction on the site of the current municipal garage: \$63 520.78.
  - 50% non-refundable QST on purchase of the garage: \$16 209.38.
  - Garage evaluation costs before purchase: \$3 149.62
- Allocation of \$48 345.91 to the allocated accumulated surplus—aqueduct from the available balance of closed loan bylaw no. 391-2004.
- Allocation of \$100 426.21 to the 2022 quarry and sandpit funds
  - Use for service from Drones Experts: \$6 503.97

- Use for road maintenance \$54 100.47
  - Use for Valoris loan repayment: \$16 015.86
  - Use for the bridge deck Tambs Rd.: \$23 805.91
- Allocation of \$18 162.84 to the unallocated accumulated surplus for the additional professional fees of the firm MNP S.E.N.C.R. for the 2021 audit not provided for in the 2022 budget.
